### Welcome: Mark Gwin

Mark welcomed the group to Blacksburg and thanked everyone for their attendance. All members introduced themselves.

**Chairmanship:** Mark is eligible to be re-elected for chairman. JS Staley moves to approve Mark Gwin, Mark Sowers seconded. Approved.

#### Discussion:

**Marketing Plan**: Jason and Valerie presented the Marketing Plan with potential revisions. There was discussion about the way NEBPI operates in relation to our Innovative Contracts section of the marketing plan. VCA will no longer be providing Redbooks to producers, so asking VBIC to provide them under resource management. Board will vote on highlighted portions and other additions tomorrow.

### Financials: Teresa

Jason reviewed the past budget year. We have been short staffed this past year, so our expenditures in programs are low. We have the opportunity to carry money over, or invest it if desired. Valerie has been added to checking account as a signor, so now any check over \$5,000 will require two signatures. Mark Gwin, Jason Carter, and Valerie Rasmussen are all signors. Currently, the limit for insurance is \$250,000. We are getting close to that ceiling, so Teresa is recommending a savings account to avoid issues with audits. Cecelia Moyer motions, JS seconds a motion to open a savings account to ensure FDIC insurance and audit compliance.



Jason updated the board about the WV Checkoff contract that Teresa is executing. WV Beef Council lost their qualifications twice since November 2015, and Teresa will be getting their books up to par so they can be re-audited and hopefully requalified as a beef council. The contract between the WV and VA beef councils runs until November 30, 2016 with the opportunity to renew at 6 months increments, or terminated with 30 days notice.

# **Budget FY17:**

Jason explains that the budget is based on expected collections and rollover money. During FY16, we have been ahead of projected collections 6 out of the last 8 months. Jason feels we may be looking at a 2% increase in collections compared to last year, putting our budget at \$418,200. Nationally, there is a projected budget of \$5mil less than last year, due to heifer retention that we are not seeing in Virginia. There is a re-apportionment nationally for Federation seats. Because VA fell below the requirement by 1%, we stand to lose one of our two Federation seats in Virginia. If that happens, we'll become the most under-represented state in the nation. The petition has been made to the USDA to keep our seat for a probationary period to prove the cattle numbers can recover.

Jason presents to the board the idea that Taylor becomes a split staff member with beef council and Virginia Cattlemen's Association. Jason's portion of staff cost will be reduced back to 15%. It was raised temporarily in April 2015 to 50%. The new labor rule will go into effect December 1, 2016 that will make any employee paid under \$48,000 per year is eligible for overtime.

Joi Saville and Bain Wilson presented the Youth Cattle Working Contest proposal.

Taylor Fix presented Farming in the Valley. A board member asked that if the project get funded, Taylor provide feedback to what the 10 misconceptions are about beef.
